# <u>The Minutes of the Meeting of Stockbury Parish Council</u> <u>held by Zoom on the 16<sup>th</sup> June 2021 at 7:20 PM.</u>

# The meeting was chaired by Parish Cllr Woods.

# 1. <u>Elected Councillor to sign their Declaration of Acceptance of Office.</u>

All elected councillors signed their Declaration of Acceptance of Office.

# 2. Election of Chairman.

It was proposed by Cllr Southern to elect Cllr Woods as Chairman, this was seconded by Cllr Cathcart and agreed by all present.

Cllr Woods accepted the position and took the Chair.

# 3. <u>Chairman to signDeclaration of Acceptance of Office.</u>

The Chairman sighed his Declaration of Acceptance of Office.
